# EU4health

The Commission and the Ukrainian government have signed an agreement associating Ukraine to the EU4Health programme. This agreement will open access for Ukraine to EU funding in the area of health. This will enable the Ukrainian health system to respond to immediate needs and contribute to long-term recovery. The programme has a total budget of €5.3 billion for 2021-27.



EUROPEAN TRAINING FOUNDATION: CALL FOR LEARNING & TRAINING RESOURCES

The European Training Foundation (ETF) has launched a programme called UA Re-Emerge(ncy): e-learning and skills development to rebuild Ukraine, supported by Ukraine's Ministry of Education and Science. The call is open to collect teaching and training materials in the following priority areas: energy efficiency, construction and restoration, and green energy. Initially the geographical focus will be on the Dnipropetrovsk region in its initial phase, with plans aiming to be rolled out in other regions at a later stage. Three projects will be selected for financing by consortia set up within countries associated with the Creative Europe programme. Ukrainian organisations will also contribute, giving grants to small-size initiatives implemented at grass root level. The call is open until 29 November 2022.

# EU4NEW 20 MILLION EUR FUNDFOR UKRAINIAN TECH START-UPS

The European Commission, through the European Innovation Council, has set up a €20 million support fund for Ukrainian innovation stakeholders to ensure their access to the EU market.

This new initiative is targeted at over 200 Ukrainian tech start-ups and offers €60.000 in funding to each project, aside from non-financial

measures like advisory and matchmaking services. It will be released with a call for proposals for networks of start-up associations, clusters, and other business organisations willing to support Ukrainian innovation stakeholders. The call is open to all business organisations, including clusters. The call is open until December 31, 2022

### THE INVESTIGATIVE JOURNALISM FOR EUROPE (IJ4EU) FUND

The Investigative Journalism for Europe (IJ4EU) fund has opened two new calls for cross-border investigative journalism projects in the European Union and EU candidate countries, including Moldova and Ukraine.

IJ4EU's Investigation Support Scheme will provide grants of between €5,000 and €50,000 to allow cross-border teams of any type to carry out investigations in the public interest. A second call under this scheme will open in January 2023.

IJ4EU's Freelancer Support Scheme will provide grants of up to €20,000 to cross-border investigative teams made up predominantly of freelance journalists. It will also provide an extra layer of support through training, mentoring and networking opportunities. The scheme will have a second call in January 2023.

CREATIVE EUROPE: COMMISSION **PUBLISHES SPECIAL CALL TO** SUPPORT UKRAINIAN ARTISTS

The call supports artists outside their country, cultural organisations in Ukraine, and preparation for the post-war recovery of the Ukrainian cultural and creative sector in the medium term. The European Commission has published a special call under the Creative Europe programme for

#### Ukrainian artists worth €5 million.

The purpose is to collect and adapt professional short modules and other e-learning resources from the EU and EU neighbouring countries, which will give Ukrainian learners the opportunity to enrol in high-quality vocational e-learning, reskilling and upskilling courses. Thus, this is not so much about formal education but more about how short modules can be of help for specific job profiles.



#### HORIZON EUROPE

Research and innovation funding programme until 2027.



Horizon Europe is the EU's key funding programme for research and innovation with a budget of €95.5 billion. It tackles climate change, helps to achieve the UN's Sustainable Development Goals and boosts the EU's

#### competitiveness and growth.

The programme facilitates collaboration and strengthens the impact of research and innovation in developing, supporting and implementing EU policies while tackling global challenges. It supports creating and better dispersing of excellent knowledge and technologies. Legal entities from the EU and associated countries can participate (including Ukraine and Moldova).


